PROTOCOL ON STUDENT EXCHANGE  
BETWEEN  
YILDIZ TECHNICAL UNIVERSITY  
AND  
UNIVERSITY OF TRIESTE

The Yıldız Technical University, represented by its Rector, Prof. Dr. İsmail Yüksek,  
And

The University of Trieste, represented by its Rector, Francesco Peroni,

Hereby agree as follows:

**Article 1**

Both Institutions, desiring to cooperate within their respective study areas and degrees, decide to establish a student exchange programme, in order to increase each Institution's teaching, learning and internationalization objectives.

To this end they provide exchange opportunities for BA and MA students for the purpose of thesis research or study, including attendance of courses, for the duration of 1 to 5 months or one semester.

The Parties will mutually agree upon the number of student exchanges to take place each year.

**Article 2**

The students participating in the exchange programme will be selected by their Home Institution.

Each exchange student shall determine the study programme at the Host Institution in consultation with the supervising lecturers of both the Home and Host Institutions.

Within the deadline of the Home Institutions selection students should receive a written acceptance of the Host Institution, which may also be used to obtain the visa, if necessary.

At the end of their stay at the Host Institution students shall be issued a certificate which attests the duration of their stay, the learning or research activities carried out and credits awarded.

**Article 3**

The students participating in the exchange will be registered at the Host Institution and shall be subject to the policies, rules and regulations of the Host Institution.

Provided they have paid the appropriate tuition and fees to their Home Institution, exchange students shall not be required to pay tuition fees at the Host Institution.

Students are responsible for acquiring the necessary visa documents.

Students participating in this programme will continue as candidates for the degree of their Home Institution and will graduate from their Home Institution.

#### Article 4

According to the rules and regulations of the Host Institution, exchange students shall be able to carry out the activities described above and shall enjoy the same rights and privileges as students of the Host Institution, such as access to libraries and to other facilities usually available.

The Host Institution will, as far as possible, provide assistance to students in order to find suitable accommodations, during their stay at the Host Institution.

#### Article 5

Exchange students will be required to have comprehensive medical cover, social security and accident insurance according to the standards of their Home country or Institution and will be responsible for taking out a complementary insurance, if necessary.

#### Article 6

This Agreement will commence on the signature of the last party to sign. It will be in effect for five years and may be renewed for other five years. This agreement may be amended through the mutual discussion and written consent of the two Institutions.

The present agreement may be terminated by either party giving 6 months prior notice by registered mail with return receipt without compromising the annual exchange programme ongoing at the time of termination of the Agreement.
